- Can often be a deciding factor between competing organisations

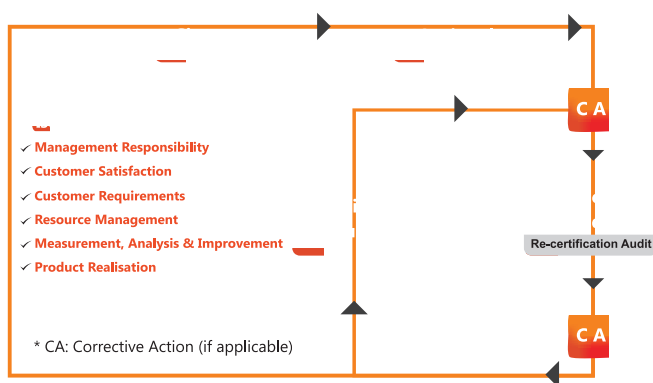

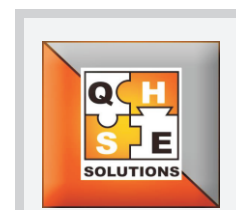
